Memorandum

Re: **Historic Irrigation Ditch Stone Use Request**

When SR-9 was reconstructed several years ago, the majority of the irrigation ditches that flanked Zion Canyon Boulevard were removed to make way for wider sidewalks and bike lanes. At that time, the Historic Preservation Commission asked the contractor to salvage as much of the historic ditch stone as possible for use in future projects around the Town. The stone is stored in the Town yard.

The Historic Preservation Commission subsequently developed a process to decide which projects would be selected to use the salvaged stone. An outline of that process is on page 2 of this report.

To date, the historic stone has been used on a number of monuments in Town including:

- Monument on Lion Boulevard to highlight the community mosaic project.
- Monument at MeMe's Café to commemorate the old irrigation ditches.
- Monument at Under the Eaves for the National Registry of Historic Places plaque.

Today, the HPC will consider another project request. Robert George, Streets Superintendent has submitted an application to build steps and a monument for an interpretive plaque to highlight the historic irrigation ditch across from the Post Office along Tiley Hill.

Commissioners should consider the request and make a recommendation to the Town Council on whether some of the historic ditch stone should be used for this project.

Salvaged Stone Process

Stone use must benefit the Town of Springdale – Not private property owners

HPC projects should be given priority on the use of the stones

Pioneer cemetery

Museum

Bishop's Granary

Step-by-step process

1. HPC to create/maintain a master inventory sheet to manage inventory of stone
2. HPC to develop a simple application form for those wishing to use stone to fill out
3. Proposals for use of the stone are presented to HPC for discussion/consideration
4. HPC decides to recommend or not recommend the use to the Town Council
5. Proposal is forwarded to Town Council with HPC recommendations
6. HPC audits the specific use of the stones to assure use is per the proposal received
7. Town staff made aware of the stone use process to assure adherence to the plan



How Can You Help Tortoises?

There are many, easy ways people can help make the easier for desert tortoises.

- Don't pick up a tortoise! Tortoises store water in their bladders to help them get through the extremely dry seasons in the desert. When startled, tortoises will empty their bladders, losing all the water they had been storing. This could cause a tortoise to die of dehydration.
- Don't litter! Tortoises can eat bits of litter, which could be lethal. Litter also attracts ravens, who will eat the litter and any tortoises near the litter.
- Stay on existing routes and trails. Off-trail travel can collapse tortoise burrows, and crush buried eggs.
