



**MINUTES OF THE SPRINGDALE TOWN COUNCIL SPECIAL MEETING
HELD MONDAY, JULY 20, 2020**

This Council meeting did not have an anchor location and was conducted entirely via electronic means. Council members connected remotely. The meeting was available to the public for live viewing/listening.

General discussion and announcements: Mr. Wixom said the Town would send out an update to the community on the drinking water system testing.

Ms. Zumpft wanted to be sure residents were informed about the safety of using river water for animals.

- Mr. Wixom indicated that to-date water column samples all came back 'non-detect'. The higher level of toxins was found in the algal layer when scraped off rocks. Should the algae be disturbed and mixed into the water, it could travel. People were asked to use their best judgement and to follow the guidance from the Division of Water Quality.
- As far as anyone was aware, no wild animals, or other domestic animals had been affected.

Mayor Smith noted Zion National Park found toxic algae above the Narrows and at the Temple of Sinawava. A 'danger' sign had been posted; however, the Narrows would not be closed. He said the Town's drinking water was not an issue and staff monitored it very closely.

Ms. Elger appreciated all the communication Council members had received about the situation. She wanted to be sure residents were receiving the same information about monitoring and test results.

Had it not been for the dog dying over the July 4th weekend, no one may have known there was a toxic algae issue. This event caused testing and scrutiny, however there was a lot the experts still did not know.

Motion made by Lisa Zumpft to go into Closed Session for a strategy session to discuss the purchase, exchange, or lease of real property; seconded by Suzanne Elger.


It was noted that Adrian Player lost his electronic connection and therefore was not present after the Closed Session adjourned.
