**General discussion & announcements:** Mayor Smith reminded Council members the importance of civility during public meetings, especially when items were emotional.

**Action Items – Administrative**

**1. Canvass of the 2019 Springdale Primary Municipal Election:** The state required the election canvass be held ten to twenty days after the election. The legislative body was the Canvass Board whose purpose was to review the election materials and make an official announcement regarding the results.

Signatures were validated by the county and the election register marked to indicate a voter had voted. Counting judges confirmed the numbered ballot sent to a voter was the same ballot returned.

Ms. Carlson indicated 367 ballots were sent, 241 ballots were received and counted, 2 ballots had unverified signatures, 1 ballot was returned undeliverable, and 2 ballots were rejected due to a late postmark.

**Motion made by Mike Alltucker to accept the canvass results as presented of the 2019 Springdale Municipal Primary Election completely and officially announce the four candidates that will move on to the general election on November 5th. Those candidates being: Suzanne Elger, Lisa Zumpft, Tyler Young and Stewart Ferber; seconded by Randy Aton.**

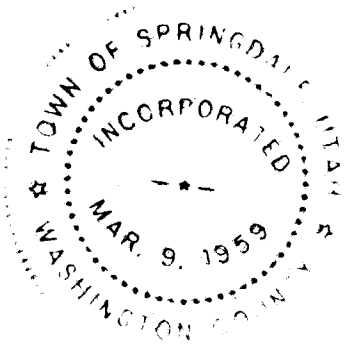
