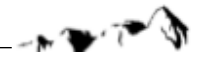

WHAT IS IT WORTH?

In the last few weeks, there's been a small but vocal group of residents questioning the compensation we pay our Town staff.

I left the workforce three years ago. I spent my last 22 years working for Herman Miller, an office furniture manufacturer. We sold high-quality furniture and provided space planning services to create great places to work. Why did our customers pay a premium to work with us? Because attraction and retention of talent was the most important thing they could do to ensure success. Happy employees create happy customers, and happy employees don't leave. It's time-consuming and expensive to train new people.

The Town is one of the few employers in Springdale that is fully staffed. Unemployment in the State of Utah is the lowest in the country. There are no people to hire. An Ongoing Conversation about Water

Below are the next articles in a series intended to educate and inform the community about important water issues.

In last month's newsletter article, we mentioned the State's regional water conservation goals. We wanted to provide a deeper dive into those regional goals in this issue. In November 2019, the Utah Division of Water Resources finalized the State's regional goals and established nine regions around the state. These nine regions each have a specific goal for water conservation. The State's goal for our region, the Lower Colorado River South region, is a reduction average GPCD of 14% by 2030 from the 2015 baseline value. Springdale's 2015 total GPCD is 1,556 gallons/person/day, which includes all irrigation or secondary water use. A 14% reduction from this amount is approximately 218 gallons/person/day, or a goal total of 1,338 gallons/person/day by 2030.

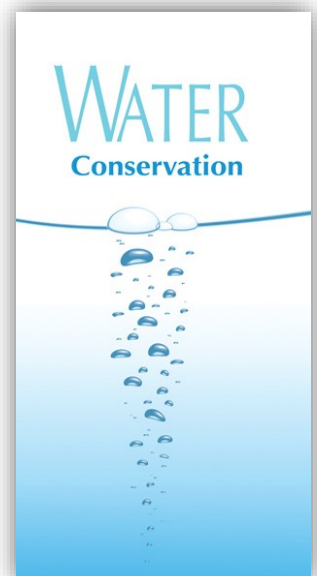

Priority Call – Virgin River & Tributaries

The Utah State Division of Water Rights has issued a priority call for the Virgin River and its tributaries (North Creek, East Fork and others). When river flows become significantly diminished due to conditions such as drought, the Division can issue a priority call, or order for certain priority water rights to stop diverting water. Utah's water laws are based on a "first in time, first in right" basis where the oldest rights have the most right to water.

The priority call was for water right holders with priority dates after 1901 to stop diverting water. The Town and SCIC water rights have a priority date of 1870. That being the case, we may still divert and use our full water right.

Conservation plays an important role in managing a priority call. If the State cannot show sufficient water for a group of users downstream, it issues the call to free up water. If upstream users are not using all their water, this can potentially alleviate the issuance or expansion of a priority call. So, when we conserve and don't use all the water that we have rights to, we may be allowing a downstream user to also have water for their use.

Do your Part to Prevent Wildfires in Springdale and Zion National Park

National Park Service (NPS) fire crews from Zion are among the more than 700 wildland firefighters who have responded to help manage the Left Fork Fire. They also responded to the Dalton Wash Fire earlier this year. NPS fire crews are highly trained to deal with wildfire and worked this winter to prepare the park for fire season by conducting prescribed burns and by continuing to study the ways fire affects the park.

For now, as we experience hot, dry conditions, you can take simple steps to reduce the chances of accidentally starting a wildfire at Zion or anywhere this summer. It's especially important to remember:

- Don't build campfires in the park when fire use is restricted (fires are not allowed in most Zion campgrounds now and are never allowed in Wilderness).
- Secure trailer chains to make sure they don't drag and spark a fire.
- Keep trailers and RVs properly maintained, including tire pressure.
- Don't park a hot car or recreational vehicle in dry grass.

Back to my career. I received cost of living adjustments and merit increases every year. If I had not, I would have looked for a new employer. My employer passed the increased cost of salaries and benefits on to our customers through price increases. The Town of Springdale has not increased its property tax rate in at least 18 years. In the next year, we're budgeted to receive \$79,000 in property taxes. Springdale is obviously not passing the increased cost of employees on to our residents. The cost is being paid by our visitors.

Most people will say that you get what you pay for. I say you don't always get what you pay for, but you don't get what you don't pay for. In this case, I think we're getting what we don't pay for, and it's a win/win.

Community Recreation Building: How did we get here and what is next?

As part of an ongoing effort to provide meaningful recreational opportunities in Springdale, the Parks and Recreation Department has been exploring different options for a community recreation building. But how did we get here?

Back in June 2021, Town Staff conducted a survey to gather feedback on more indoor recreation to assess the level of interest from Springdale residents. The responses were varied, but we did notice several trends and recurring themes as we went over the data, including information on general interest in indoor recreation, what types of recreation people were most excited about, willingness to pay membership fees, how often users would use an indoor recreation facility, etc.



While the Canyon Community Center has served admirably for many of the Town's recreational needs for many years, a new recreation facility would alleviate some of the scheduling issues we've recently experienced at the community center and allow us to provide the additional services that were mentioned in the community survey such as indoor basketball and dedicated fitness areas.

As we continued to review the results, we began to identify possible areas in town where a new facility might be built. We took into account the Town's desire to preserve open space in addition to the convenience and practicality of the location. One area that showed promise was the infield portion of the ball field. While building in that location would effectively eliminate the baseball infield, it would allow us to preserve most of the surrounding green space, which is often used for large gatherings and festivals, and used by many residents to run their dogs, play disc golf, and more.

Recently the Town entered into an agreement with Naylor Wentworth Lund Associates, an architectural firm to further explore the possibility of building a recreation building. They are in the very beginning concept and programming phases of the process, which include understanding the Town's needs, exploring the feasibility of such a project, gathering feedback from community members, and drafting preliminary floor plans and building elements.

The next step in this process will rely heavily on you, the Springdale resident. Because this building will primarily be used by residents, we want to know what you think about indoor recreation and what would be of most value to you. Over the coming weeks and months, the architects will work with Town staff to solicit feedback and input from the community. While the exact dates and details of these efforts are yet to be determined, we want to make sure everyone is aware of the upcoming planning process.

We are excited to serve you and hope you will continue to provide us with your valuable feedback. More information will be forthcoming, but if you have any questions in the meantime, please contact Ryan Gubler at (435)772-3434.

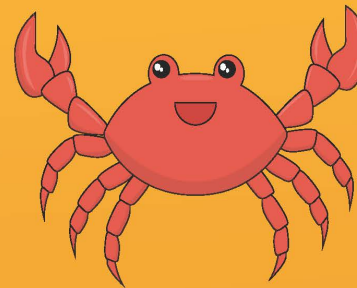
